MILL LEVY CERTIFICATION

Taxes shall be distributed as specified in the Board's Order prepared by the Administrative Director, in coordination with the County Assessor". Administrative Director, Renee' Obermueller provided copies of the Order, there were no members of the public in attendance and no questions by Commissioners.
