

MINUTES OF THE BOARD OF SHERIDAN COUNTY COMMISSIONERS

Pursuant to Wyoming Statute 39-13-102(g), the Board of County Commissioners met in special session on August 3, 2009, at 1:30 p.m., Sheridan County Courthouse. Members present were Commissioners Steve Maier, Mike Nickel, and Tom Ringley. Commissioners Robert L. Rolston and Terry Cram were absent. Chairman pro tem Steve Maier convened the meeting for the purpose of certifying tax levies for the collection of ad valorem taxes for fiscal year 2009-2010. Administrative Director Renee Obermueller commented there was only one change from the previous year, that being a request from School District 3 to reduce the levy for Recreation from one mill to one-half mill. Having been prepared by Ms. Obermueller and approved by County Assessor Paul Fall, mill levies for applicable governmental entities were certified by Order of the Board of County Commissioners.
