**SHERIDAN HOUSING ACTION COMMITTEE**

Director Marie Lowe advised that SHAC would be applying to HUD for status as a community housing development organization and would be requesting operating funds from the

federal HOME program. Ms. Lowe said an application would also be submitted for \$500,000 to create a gap-financing pool through the HOME program to assist qualified homebuyers of affordable housing units. She said SHAC is working with local lenders to supply the \$25,000 match. To facilitate accomplishing these goals, the Board approved allocating \$10,000 to SHAC so that a grant writer could be retained to prepare the necessary applications.

#### SHERIDAN COUNTY AIRPORT

The Board approved a Lease Agreement with ROVAR, LLC dba Avis Rent a Car and Budget Car Rentals for a 15-year term authorizing counter space in the Airport terminal building, with all other terms and conditions as set forth in the agreement, which includes a Concession Fee.
