

SHERIDAN COUNTY COMMISSIONERS MINUTES

Pursuant to Wyoming Statute 39-13-102(g), the Board of County Commissioners met in special session on August 6, 2007, at 1:30 p.m. in the Sheridan County Courthouse. The Board convened as the Board of Equalization for the purpose of certifying tax levies for the collection of ad valorem taxes for fiscal year 2007-2008. Members present were Chairman Terry Cram, Commissioner Steve Maier and Commissioner Robert L. Rolston.

Being approved by Assessor Paul Fall and Administrative Director Renee Obermueller, levies for applicable governmental entities were certified by the Board, all being within the limits provided by State Statute.
