#### INSPECTION FEE SCHEDULE Enclose inspection fee payable to Sheridan County.

- a. Open Trench Installation or repair, perpendicular to roadway centerline: \$500.00 plus \$5.00 per foot of installation. Compaction tests required under roadway.
- b. Open Trench Installation or repair, parallel to the roadway centerline: \$500.00 plus \$2.00 per foot of installation. Compaction tests required under roadway.
- c. Plowed type installation. \$500.00 plus \$ .20 per foot of installation.
- d. Overhead installation with poles or structures in County ROW \$500.00 Plus \$ .20 per foot of installation
- e. Overhead installation without poles or structures in County ROW \$150.00 Plus \$ .20 per foot of installation
- f. Bored crossing \$150.00 Plus \$ .10 per foot of installation, or repair.

Exceptions

- a. Service for individual residences are exempt from charges, however, an application must be filed with the County Public Works Department.
- b. In case of joint trench installation, only one fee will be charged. All utilities using the joint trench shall be listed on the application.
- c. In case of repair work, the fee will be charged only when work disturbs roadway surface.

If an **exception** is desired, Applicant shall submit a request in writing to the County Public Works Department. The Department shall review the request and make a recommendation to the Board of County Commissioners. The Board of County Commissioners shall consider the proposed exception and take action to accept, reject, or modify the proposed exception.
