- Upon review of the plat by the Public Works Department, the applicant will be notified of any changes needed on the plat to bring the plat into conformity with the standards of the County Subdivision Resolution or questions,
- Once the applicant has submitted a revised plat and addresses Staff's questions, Staff will schedule the item on the Planning Commission's agenda,
- Upon a decision by the Planning Commission, the subdivision request will be forwarded to the County Commissioners and placed on their agenda.
- All advertising charges will be billed to the applicant by the Sheridan Press
