SUPPORTING INFORMATION: (ATTACH TO APPLICATION)

Plot Plan showing (TO SCALE):

1. Property lines with bearings and distances, and area of parcel. **A survey of the property is preferred or copy of a plat if within a subdivision,**
2. Point of access to public road/easement,
3. Location of easements, ditches, floodplain and/or bodies of water (creeks, ponds, etc...),
4. Proposed and existing structures and distances to all property lines for front, rear and side yards,
5. Building layout,
6. Location of required parking spaces.

Copy of approved access permit from applicable agency (WYDOT, Sheridan County, etc.)

All supporting information **must** be included with each application or there will be a fee to make copies.

*Fee (To be paid upon submittal of application - nonrefundable) \$150.00. **New construction commenced prior to permit approval-\$300.00**

Upon Approval of the Permit:

- A site inspection will be performed. New construction must be clearly staked out as per the plot plan.
- Please call to schedule an inspection once the building location is staked. Existing survey monuments must be flagged and visible to the inspector. Call at least 24 hours prior to the date you want the inspection.
