Motion by Commissioner Nickel to approve a temporary permit extension beginning on July 17, 2017 and terminating on the date that the Board of County Commissioners may approve a new quarry permit application, but in no case should it extend beyond six months following consideration of this request, and further, being subject to any applicable conditions established with Q-07-002.
