#### MINUTES OF THE BOARD OF SHERIDAN COUNTY COMMISSIONERS

The Board met at 9:00 a.m., Tuesday, April 15, 2014, in regular session in the Commission Board Room, County Courthouse, Sheridan, Wyoming. Chairman Terry Cram called the meeting to order and led the Pledge of Allegiance. Members present were Commissioners Terry Cram, Steve Maier, Mike Nickel, Tom Ringley and Bob Rolston.

#### **CONSENT AGENDA**

Commissioner Rolston moved to approve the consent agenda as published and authorize the Chairman to sign documents as required. The motion carried with all voting in favor, following are the consent items:

Commissioner Ringley moved to approve the agenda as published. The board voted in favor and the motion carried.

Chairman Cram mentioned the board's grant match of \$6,000 to the TRVJPB, proposed Kleenburn rule change, Free Landfill Days/Trees for Trash dates, an opening on the Planning and Zoning Commission, the Commission scholarship application deadline, and the courthouse early closure for Good Friday.

#### **PUBLIC COMMENTS**

There were no public comments.

## **CLERK OF DISTRICT COURT SECURITY UPGRADES**

Following a staff report from Mike Mackey, Grants Administrator, Commissioner Rolston moved to award and authorize the Chairman to sign associated contract documents to O'Dell Construction Inc. for the Clerk of District Court Security Upgrades in the amount of \$63,700. This project is funded through a Wyoming Office of Homeland Security Grant. The motion carried with all voting in favor.

# TANF/CPI GRANT APPLICATIONS

Mr. Mackey explained the annual TANF/CPI grant application process. Kim Schweikert, Sr. Director of Adult and Community Services from Easter Seals Wyoming detailed this year's proposal. Susan Carr, Executive Director for Child Advocacy Services of the Big Horns also addressed the board with their request. Commissioner Ringley moved to award the Temporary Assistance for Needy Families Community Partnership Initiative (TANF/CPI) Grant to Child Advocacy Services of the Big Horns in the amount of \$30,000 and Easter Seals Wyoming in the amount of \$15,000. All voted in favor and the motion carried.

#### OFF AIRPORT AUTOMOBILE RENTAL CONCESSIONS AGREEMENT

Following a staff report from John Stopka, Airport Manager, Commissioner Nickel moved to approve and authorize the Chairman to sign an Off Airport Automobile Rental Concessions Operating Agreement with Enterprise RAC Company of Montana/Wyoming, LLC, for a 3 year term. The fee is 10% of the total gross receipts, payable monthly, effective May 1, 2014 – April 30, 2017. The motion passed with all voting in favor.

# FEDERAL EXPRESS COROPORATION LEASE

Mr. Stopka explained the proposed lease renewal and Commissioner Rolston moved to approve and

authorize the Chairman to sign a Lease Agreement with Federal Express Corporation for a 3 year term with an option to extend an additional 2 years. The rental rate increases 7.3% bringing it to \$29,316 per year effective May 1, 2014. The motion passed unanimously.

## **RESOLUTION 14-04-011 AIRPORT RESTRIPING MATERIALS GRANT**

Following a staff report from Mr. Stopka, Commissioner Maier moved to adopt and authorize the Chairman to sign Resolution 14-04-011 approving a grant application to the Wyoming Department of Transportation, Aeronautics Division for the purchase of paint and beads to restripe taxiway B, commercial aprons and associated taxilanes. Project total is \$6,000 with State Aeronautics contributing \$4,800 and the airport funding the remaining \$1,200. All voted in favor carrying the motion.

## **RESOLUTION 14-04-012 NOI – PUBLIC FACILITIES ZONING AMENDMENT**

County Planner, Mark Reid, detailed the Planning and Zoning Commission's proposed zoning change. Commissioner Ringley moved to adopt and authorize the Chairman to sign Resolution 14-04-012 giving public notice of Sheridan County's intent to amend the Rules and Regulations Governing Zoning in Sheridan County, deleting "Public Facility" from the table of permitted uses in Section 17 of Zoning Rules. The board voted unanimously in favor, motion carried.

# **RESOLUTION 14-04-012**

RESOLUTION GIVING PUBLIC NOTICE OF SHERIDAN COUNTY'S INTENT TO AMEND THE RULES AND REGULATIONS GOVERNING ZONING IN SHERIDAN COUNTY, WYOMING WHEREAS, Wyoming Statutes §§ 18-5-101 to 18-5-107; 18-5-201 to 18-5-208 authorize the Board of County Commissioners for Sheridan County ("Board") to promote the public health, safety, morals and general welfare of the county by regulating and restricting the location and use of buildings and structures, and the use, condition of use or occupancy of lands for residence, recreation, agriculture, industry, commerce, public use and other purposes in the unincorporated area of the county; and

WHEREAS, a "Public Facility", is not a permitted uses in any zoning district as provided for in the Rules and Regulations Governing Zoning in Sheridan County, Wyoming; and

WHEREAS, land use compatibility should be evaluated based on impacts to the community, rather than on whether a use is held privately or publicly; and

WHEREAS, on March 6, 2014, pursuant to Section 27.C. of the Rules and Regulations Governing Zoning in Sheridan County, Wyoming, the Planning & Zoning Commission initiated proceedings to amend said Rules; and

WHEREAS, the purpose of the proposed amendment is to delete "Public Facility" from the Table of Permitted Uses in Section 17 of said Rules as proposed in Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF SHERIDAN COUNTY, WYOMING, that the Board hereby gives notice to the public that Sheridan County intends to amend the Rules and Regulations Governing Zoning in Sheridan County, Wyoming as noted above. Copies of the proposed amendment may be obtained from the Sheridan County Commissioners' Office or County Public Works Department, 224 S. Main Street, Sheridan WY.

IT IS FURTHER RESOLVED that the Planning and Zoning Commission shall hold a public hearing on June 5, 2014 at their regularly scheduled meeting at 5:30 p.m. in the Commissioners Board Room, second floor of the County Courthouse, Sheridan WY; and that all interested persons may submit written comments to the Public Works Department, 224 S. Main Street, Sheridan WY 82801, no later than 12 Noon on May 27, 2014.

IT IS FURTHER RESOLVED that the Board of County Commissioners shall hold a public hearing on July 1, 2014 at their regularly scheduled meeting at 9:00 a.m. in the Commissioners Board Room, second floor of the County Courthouse, Sheridan WY; and that all interested persons may submit written comments to the Public Works Department, 224 S. Main Street, Sheridan WY 82801, no later than 12 Noon on June 23, 2014.

Chairman Cram opened a public hearing; Ms. Myers gave details regarding the malt beverage license. There were no public comments and Commissioner Ringley moved to approve and authorize the Chairman to sign the 2014-15 County Malt Beverage License Renewal for Double Rafter Inc. dba Double Rafter Cattle Drives. The board voted in favor approving the motion.

# **2014-15 RESTAURANT LIQUOR LICENSE RENEWAL**

A public hearing was opened by Mr. Cram the renewal was explained by Ms. Myers. There were no public comments and Commissioner Rolston moved to approve and authorize the Chairman to sign the 2014-15 Restaurant Liquor License Renewal for Cantadas LLC dba Big Horn Mercantile. The motion passed with all voting in favor.

# **FIREWORKS PERMIT**

Commissioner Ringley moved to approve and authorize the Chairman to sign a Permit for Supervised Public Display of Fireworks for Lannie Geist on May 24, 2014 at 158 Upper Prairie Dog Road, Banner. All voted in favor and carried the motion. Commissioner Maier pointed out the applicant is not in a fire district and any costs for EMS or fire calls will be charged to the landowner. He encouraged the owner to petition for inclusion in the Story Fire District.

# **2014 CHIP SEAL PROJECT**

Rod Liesinger, Director of Public Works, detailed the bids and listed the following roads to be partially chip sealed this summer: Mydland Road; Paradise Park Road; Metz Road; Upper Road; Swaim Road; and Knode Road. Commissioner Rolston moved to award and authorize the Chairman to sign associated contract documents for the 2014 Chip Seal Project to Intermountain Slurry Seal Inc. in the amount of \$240,235.00. Funding for this project will be Sheridan County Road Funds; the motion passed unanimously.
