Mr. Maier also announced a public meeting for the pending Flood Insurance Rate Maps, the Notice of Intent for Flood Plain Management Regulations, the CAP Tax website address, the upcoming Free Landfill weekends, and the award received by Commissioner Nickel, Chairman, for the WCCA Health, Safety and Social Services Committee of the Year.

PUBLIC COMMENTS

There were no public comments.

V-13-001: MCGREGOR LOT SIZE VARIANCE

Chairman Maier opened a public hearing at 9:06 a.m. and received a staff report from Mark Reid, County Planner. There were no public comments or comments from the applicant, Joyce McGregor. Chairman Maier closed the public hearing at 9:08 a.m. Commissioner Cram moved to approve item V-13-001: McGregor Lot Size Variance as per the submitted application. Commissioner Ringley seconded the motion and it passed with all voting in favor. Mr. Maier stated the board would issue findings of fact to support this decision.

Q-13-006: S.K. JOHNSTON QUARRY PERMIT

Chairman Maier opened a public hearing at 9:09 a.m. and received a staff report from Mr. Reid. Martin McCarty was present to represent the application, there were no questions from the public or the board. Mr. Maier closed the hearing at 9:11 a.m., Commissioner Rolston moved to approve item Q-13-006: S.K. Johnston Quarry Permit as recommended by the Planning and Zoning Commission with the conditions as stated in the staff report. Commissioner Nickel seconded the motion and the board voted in favor. Mr. Maier stated the board will issue findings of fact to support this decision. Following are the conditions:

- 1. Applicant shall cooperate with the County Engineer on any matters dealing with the integrity and safety of county roads that are used from hauling.
- 2. The permit shall be effective for **five years**, commencing on the date approved by the BOCC.
- 3. Hours of operation are Monday-Friday 7:30 a.m. to 5:00 p.m., Saturday 7:30 a.m. to 1:00 p.m. and no hours of operation on Sunday.
 - 4. That the area encompassed by previous permit Q-08-004 be covered under this permit.

HISTORIC PRESERVATION

Commissioner Ringley moved to appoint Alfred Hendrickson to the Historic Preservation Commission for an expired, 3 year term, until November of 2015, Commissioner Nickel seconded the motion and it passed with a unanimous vote.

Commissioner Ringley moved to reappoint Sukey Ross to the Historic Preservation Commission for a 3 year term until November of 2016. The motion was seconded by Commissioner Cram and passed with all voting in favor.

TONGUE RIVER ROAD (CR 92) STREAMBANK STABILIZATION PROJECT

Following a staff report from Ken Muller, County Engineer, Commissioner Ringley moved to award and authorize the Chairman to sign associated contract documents to CDS Excavation for the Tongue River Road Streambank Stabilization Project in the amount of \$53,292.20. Commissioner Rolston seconded, all voted in favor, and the motion passed.

KOOI ROAD (CR 93) STREAMBANK STABILIZATION PROJECT

Upon the recommendation of Mr. Muller, Commissioner Cram moved to award and authorize the Chairman to sign associated contract documents to DRM, Inc. for the Kooi Road Streambank Stabilization Project in the amount of \$147,500.40. The motion was seconded by Commissioner Rolston and passed unanimously.
