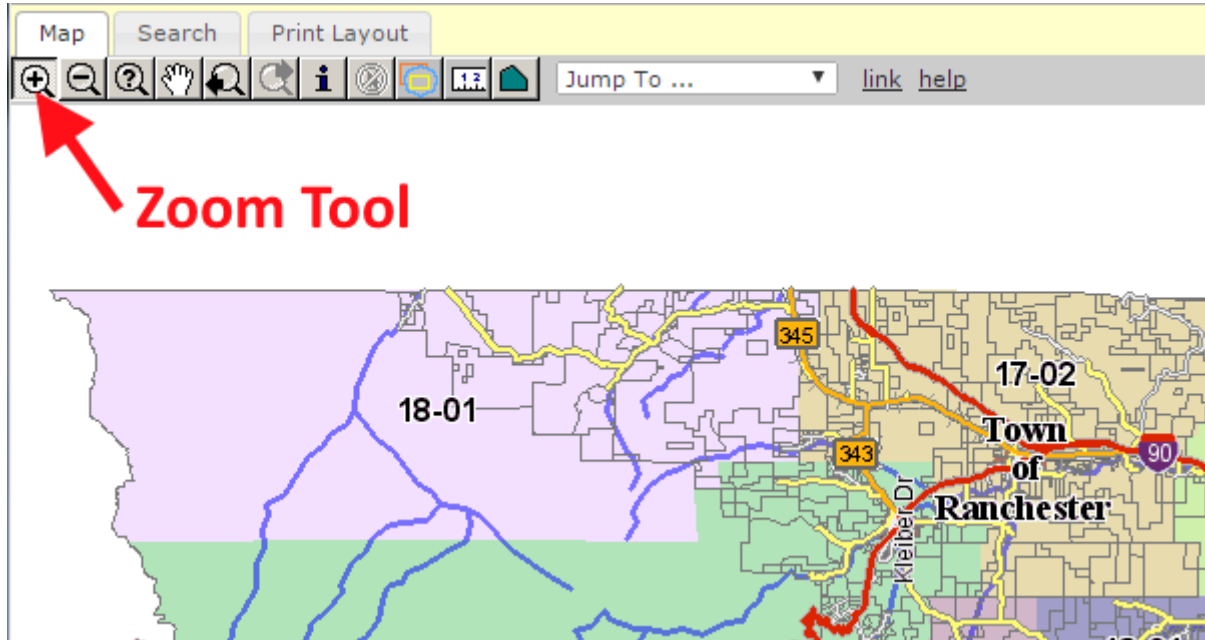


## Instructions for Viewing Sample Ballots Online

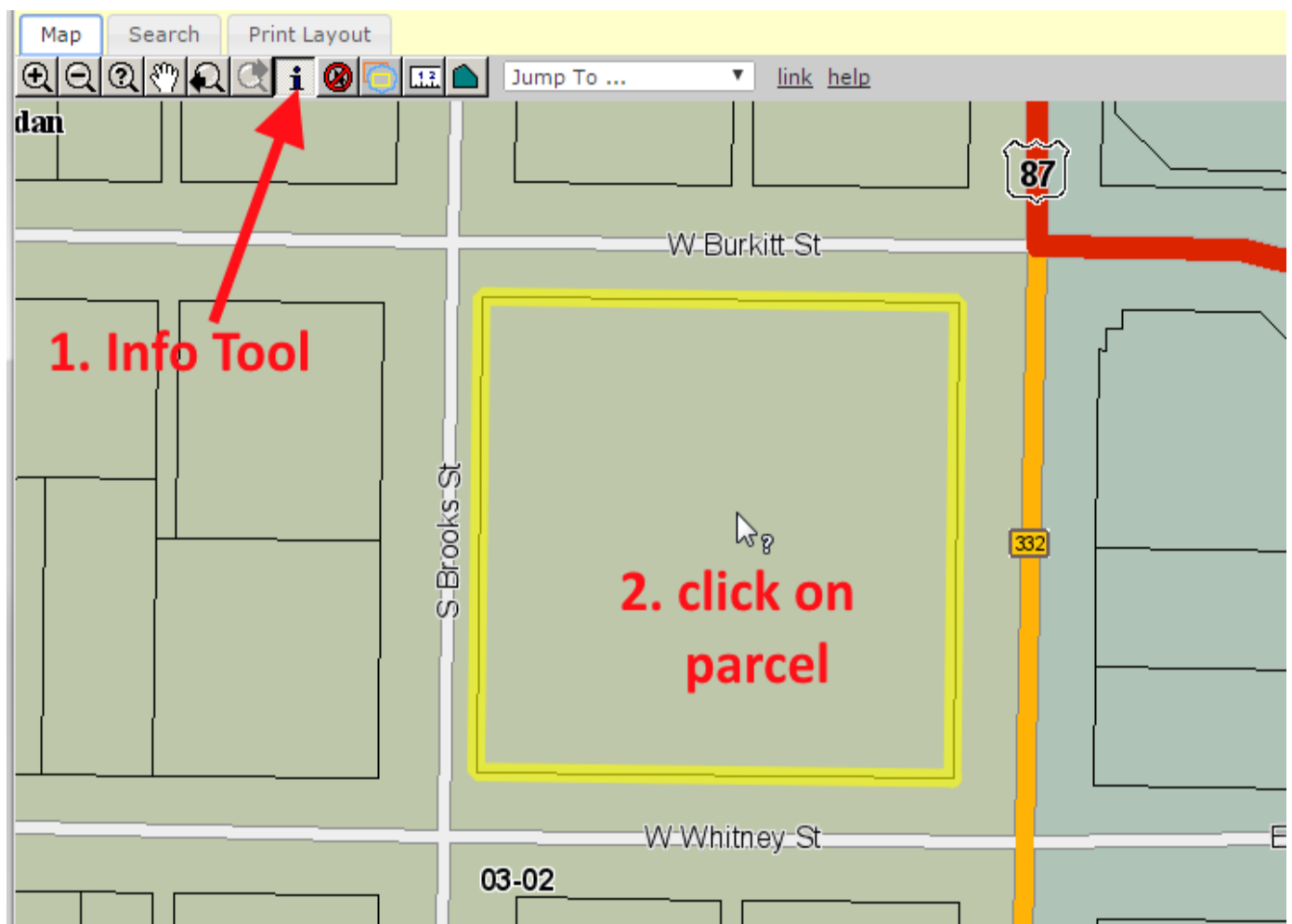
Go to our online map server at:

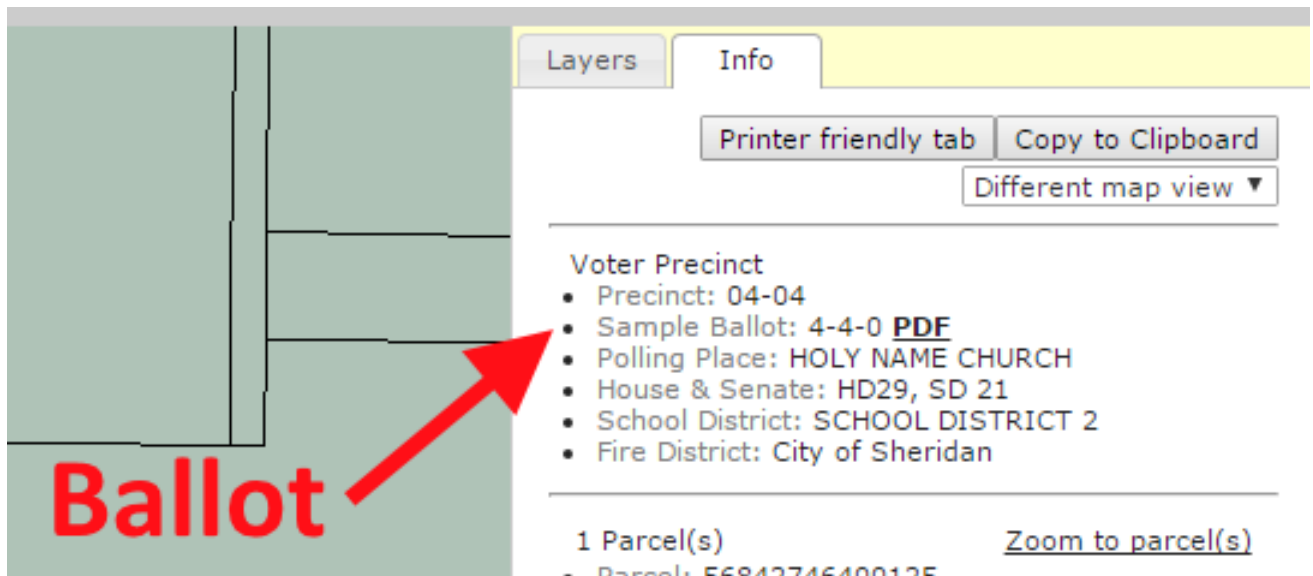
Find your property using the Zoom tool.



After you have zoomed into your property. Find the Info tool on the toolbar and click on it. Then click on your property so that it is highlighted with a yellow border.



On the far right upper side of your screen you should see a white panel with information about your property. If you click on **PDF** next to Sample Ballot you can view the specific ballot for your precinct.
