<p>The Tongue River Joint Powers Board is waiting for loan approval from the USDA for a \$4 million loan to build a natural gas pipeline from Shridan to Dayton and Rancheater. We are also waiting for approval from Wyoming SLIB on a \$1 million grant. Our goal is to keep working toward bringing natural gas to the Tongue River Area. We have completed most of the engineering studies required for the pipeline and are budgeting for further design work. Legal is budgeted the same as last year due to loan and grant application reviews. The three partners are being asked for more investment money this year to build a checking account balance large enough to start construction if a loan and/or grant is obtained.</p>
