

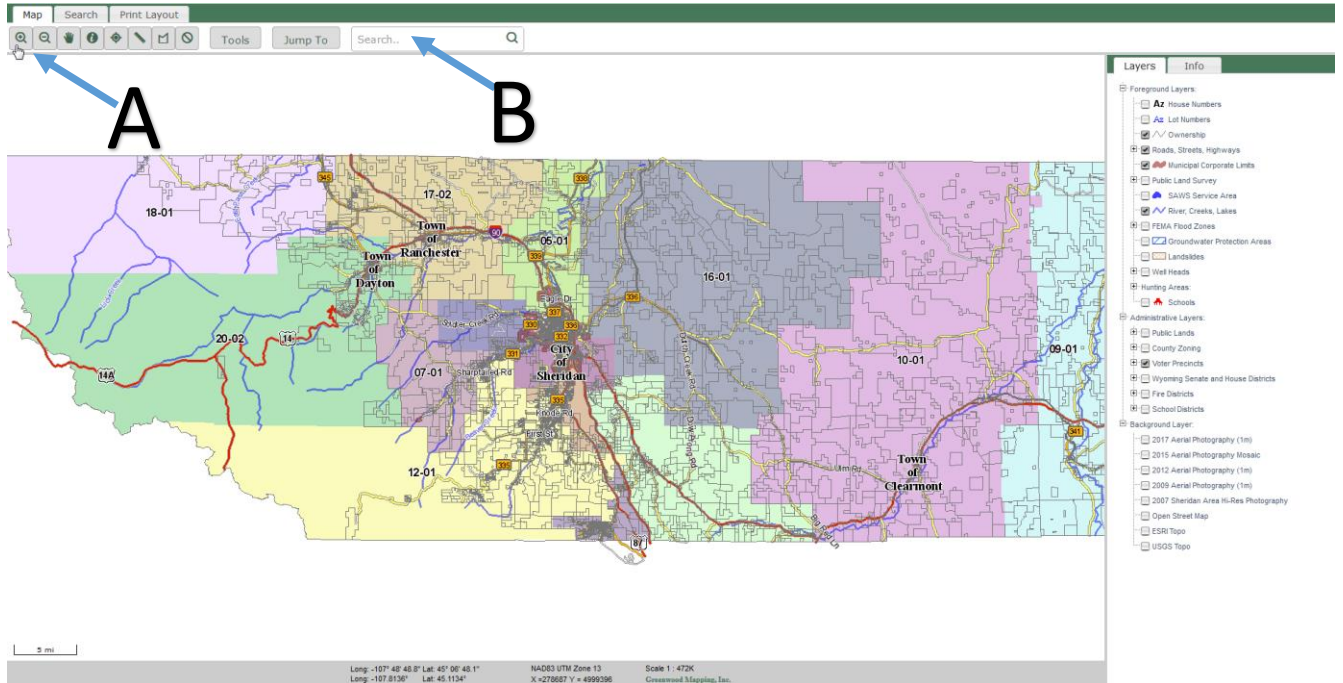
## Instructions for Viewing Sample Ballots Online

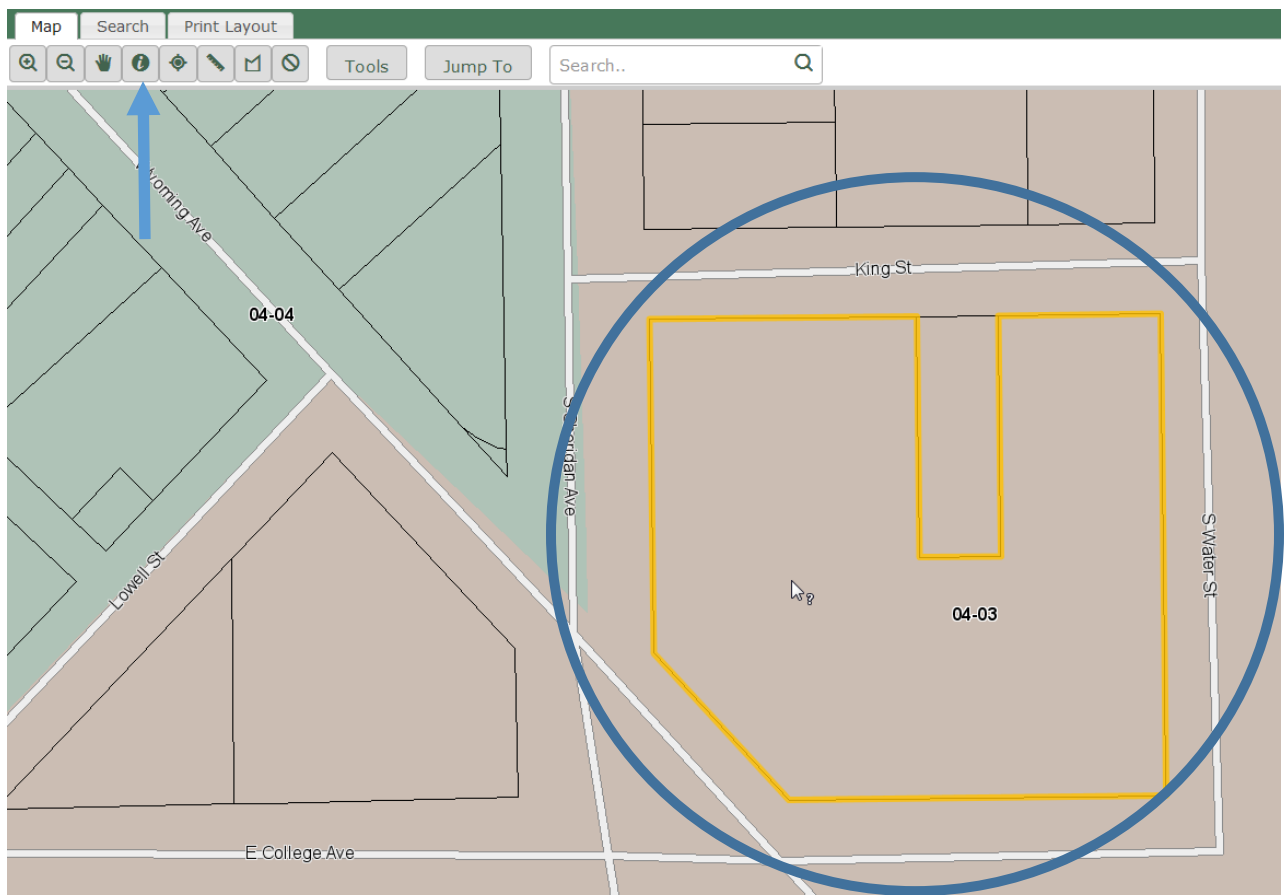

Find your property by using the Zoom tool (A). Or by searching for your address by typing it into the search box (B).



After you have zoomed into your property, click on your property so that it is highlighted with a yellow border. (if the parcel does not highlight make sure the Info tool is active by clicking on the  Icon)



On the far-right upper side of your screen you should see a white panel with information about your property. If you click on the 'Sample Ballot' you can view the specific sample ballot for your precinct.

THE ADOPTION OF THIS AMENDMENT WOULD ALLOW THE FUNDS OF COUNTIES, CITIES AND OTHER POLITICAL SUBDIVISIONS TO BE INVESTED IN EQUITIES TO THE EXTENT AND IN THE MANNER THE LEGISLATURE MAY ALLOW BY LAW.
