

Sheridan County Parks and Recreation Board

The Sheridan County Board of County Commissioners is accepting applications for seven (7) open positions on the Sheridan County Parks and Recreation Board. Sheridan County will initially appoint two (2) members to a one-year term, two (2) members to a two-year term, and three (3) members to a three-year term. Thereafter, appointments for a full term shall be for three (3) years.

The purpose of the Sheridan County Parks & Recreation Board is to establish, improve, develop, administer, operate and maintain Sheridan County public parks and recreation system which provides participation opportunities for all Sheridan County citizens. This philosophy will be pursued in a professional manner and quality, always mindful of the public trust that this Board has been given.

Current Sheridan County Parks & Trails – 2020

Three-Poles Recreation Site:

Located: North of Sheridan in Beatty Gulch

Section 36, T57N, T84W

Sheridan County entered into a Special Use Leas No. SU-609 with the State of Wyoming Board of Land Commissioners in December of 2008 for the use and operation of this recreation area.

The Public Land Users Committee (PLUC) is responsible for the oversight & maintenance of the area.

(approximately 69.4 acres, located 6 miles north of Sheridan)

Kleenburn Recreation Area

Located: Off I-90 near Acme

Sections 20 & 21, T57N, R84W

(approximately 80 acres -reclaimed form the abandoned Kleenburn Mine)

Story Centennial Park

Located: Near the Fish Hatchery two miles west of Story on State Highway 194
Section 13, T53N, R84W of the 6th Principal Meridian

Leased by the Sheridan Area Recreation District, through agreement with the County & Sub-Agreement with Story Park Board to manage the park.

(approximately 10 acres)

Bear Davis Park, Little Goose Canyon

Located: At the end of Little Goose Canyon Road near the base of the Bighorn Mountains.

Section 12, T53N, R85 (S 1/2 of NW 1/4 & SW 1/4 of NE 1/4)

(approximately 120 acres)

The Recreation Complex

Located: Between Sheridan and Ranchester on Keystone Road

Sheridan County Sportsman Association & the Flying Cowboys currently lease the area from the County.

Sportsman Association provides firearms, outdoor trap & skeet ranges, indoor pistol range, and indoor/outdoor archery and rifle ranges.

Flying Cowboys utilize a small runway to fly their small aircraft.

(approximately 560 acres, obtained from the BLM, through a federal land patent)

Trail Systems:

Sheridan County and Sheridan Community Land Trust partners in the Trail System.

Red Grade Trail System

Location: From Sheridan, South on Highway 335 for about 10 miles from the intersection of Brundage Lane and Coffeen Avenue. The last half mile is a well-maintained gravel road.

Description: Trail System located on State & Bureau of Land Management (BLM) land at the foot of the Bighorn Mountains.

Looping trail 5.7 miles in length.

(T/R/S); 54N 85W Section 27

(approximately 320 acres)

Soldier Ridge Trail and Hidden Hoot Trail

Location: From Sheridan, West on 5th Street (Hwy. 330) about five minutes from downtown Sheridan. When the pavement turns to gravel, take the second left and cross a cattle guard. Turn right into the trailhead parking area.

Description: Soldier Ridge Trail is 4-mile, non-motorized trail.

Classic Soldier Ridge Trail is 4.1 miles

Hidden Hoot Trail is a 3-mile lollipop trail – connects with the Sheridan Pathways system on West 5th Street just past the Big Horn Y West gas station.

Two Conservation Easements protect 1,154 acres along Soldier Ridge.
