S-A BUDGET MESSAGE W.S. 16-4-104(d)

Income and expenses in 2019-20 are forecast to be quite similar to the forecast for the prior year. In 2018-19 we planned to buy SCBA's for our firemen at a cost of \$100,000. We have postponed that purchase and have budgeted \$85,000 for the purchase of a used 3000 gallon water tanker. The truck that we were given in 2017 to convert to a tanker did not turn out as hoped. The conversion and equipping of the truck was more expensive than estimated and the truck was not as versatile in our kind of country as needed. The old truck still has its uses, but the new truck will give us the capacity and versatility that is needed, particularly in rough terrain. Our new fire chief is committed to having the right equipment to do the job. We request funding from the 3 mill levy as reflected in the budget

S-B RESERVE DESCRIPTION

We have not had a dedicated reserve. We have a \$58,250 CD that we have considered a reserve and we carry excess cash in our checking account. We propose to dedicate the CD to a reserve and transfer \$100,000 to a noncommitted reserve. We will revisit the funding of a reserve annually.
